

**SIGNAL HILL EQUITY PARTNERS GP INC.**  
**REPORT UNDER THE *FIGHTING AGAINST FORCED LABOUR AND CHILD LABOUR IN***  
***SUPPLY CHAINS ACT (CANADA)***  
**FOR THE FINANCIAL YEAR ENDED DECEMBER 31, 2023**

Signal Hill Equity Partners GP Inc. (“**Signal Hill**”, “**we**” or “**our**”) is filing this Report in its capacity as an entity that controls Romet Limited (“**Romet**”) and Urban Life Solutions Inc. (“**ULS**”).

Romet is an Ontario corporation headquartered in Mississauga, Ontario. Romet provides natural gas measurement and solutions to customers. Romet predominantly sources its products and parts from suppliers located in Ontario. Romet has separately reported under the Canadian *Fighting Against Forced Labour in Supply Chains Act*. A copy of Romet’s report is available on its website.

ULS is an Alberta corporation headquartered in Calgary, Alberta with operating locations in Calgary, Red Deer, Edmonton, Ottawa and Toronto. ULS’ business is to provide the following services: professional landscape management; snow and ice management; towing, recovery and storage; road sweeping and water truck services; and asphalt paving, repair and enhancements. While ULS is primarily a services business, ULS may be considered to distribute a limited number of goods in support of its services business, including landscaping material and asphalt. These materials are sourced primarily from suppliers located in Canada. ULS has separately reported under the Canadian *Fighting Against Forced Labour in Supply Chains Act*. A copy of ULS’ report is available on its website.

Signal Hill does not itself produce, sell or distribute goods in Canada or elsewhere, or import into Canada goods produced outside Canada. During the financial year ended December 31, 2023, Signal Hill did not implement any policies, due diligence processes or remediation measures, undertake any identification activities, provide any training to employees, or take any specific steps in relation to forced labour or child labour in supply chains.

This Report was approved pursuant to subparagraph 11(4)(a) of the Canadian *Fighting Against Forced Labour in Supply Chains Act* by the board of directors of Signal Hill Equity Partners GP Inc. for the financial year ended December 31, 2023.

In accordance with the requirements of the Act, and in particular section 11 thereof, I, the undersigned, hereby attest that I have reviewed the information contained in this Report for the entity listed above. Based on my knowledge, and having exercised reasonable due diligence, I attest that the information in this report is true, accurate and complete in all material respects for the purposes of the Act, for the reporting year listed above. I am providing this attestation in my capacity as a director of Signal Hill Equity Partners GP Inc., and not in my personal capacity.
